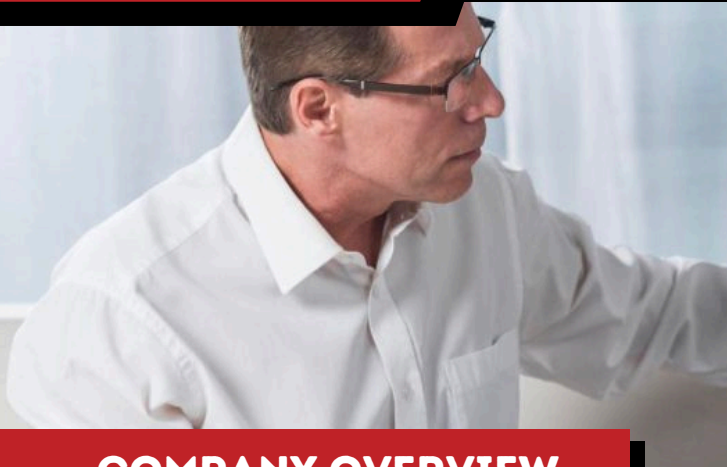




CAPABILITY STATEMENT

Our services cater to individuals of all ages, including youth-focused therapy, school-based interventions, and crisis response for universities. HBHS also supports homeless and veteran populations with housing, recovery services, and case management, making us a comprehensive resource for mental health and community support.
